Modern slavery and human trafficking

This declaration, is issued in accordance with section 54(1) of the Modern Slavery Act 2015, serves as NOW Medical Staffing's slavery and human trafficking Statement for year ending March 2022, until future modification or amendment. All our current and future employees and temporary staff will be informed of any such revisions or amendments. NOW Medical Staffing Board adopted the declaration on February 1, 2022, and it will be sent to all our clients to ensure they understand and adhere to our values.

Introduction

Where people's rights are violated because "modern slavery" refers to crimes including enslavement, bondage, forced labour, and human trafficking. It involves the perpetrator acting as though they "owned" the victim, robbing them of their freedom, using force for the individual to live on another person's property and making it impossible for the individual to leave that condition. Human trafficking is the use of direct or indirect threats of violence to force people to perform work or service for which they have not offered themselves voluntarily, and the planning of travel facilitation for another individual with the intention of exploiting them.

Modern Slavery Statement

To ensure that modern slavery is not taking in our own business, or in the supply chains in which we operate, we uphold a zero-tolerance policy for slavery and human trafficking. We are also committed to acting ethically in all our business dealings and relationships. We always uphold the highest levels of professionalism and abide by all rules and legislation that are relevant to the industry.

NOW Medical Staffing operates nationally and due to the nature of its industry, there is little chance that we are involved in or complicit in modern slavery or human trafficking, either in our

own business, or in the organisations we supply to. We are devoted to enhancing our procedures to ensure to human trafficking and modern slavery does not happen within our business and our part to putting an end to it.
